Seller further agrees to execute and deliver without further consideration any further application, assignments or other documents and to perform such other lawful acts as SDGI or Medtronic, or either of their successors or assigns may deem reasonably necessary to fully secure, maintain and enforce the rights, title or interest as specified hereunder.

3. Seller further agrees that this Trademark Assignment and attached Schedule may be filed with the United States Patent and Trademark Office or any pertinent foreign Trademark Office.
