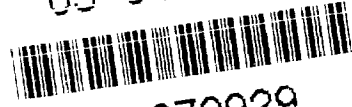

The undersigned president and assistant secretary of Duke Designs, Inc., a corporation formed under the laws of the State of Colorado, hereby certify as follows:

- A. The name of the corporation is Duke Designs, Inc.
- B. The following amendments to the corporation's articles of incorporation were adopted pursuant to Section 7-110-103 of the Colorado Business Corporation Act:
  - 1. That the articles of incorporation of Duke Designs, Inc. are hereby amended by amending and restating Article I in its entirety as follows:

ARTICLE I  
NAME

The name of the Corporation is Smartwool Corporation.


- 2. That the articles of incorporation of Duke Designs, Inc. are hereby amended by amending and restating Section a. of Article VII thereof in its entirety as follows:
  - a. Authorized Shares. The aggregate number of shares which the Corporation shall have the authority to issue is ten million (10,000,000) shares of common stock, at no par value.

C. The date of the adoption of these amendments was as of March 20, 2001.

D. The foregoing amendments were adopted by a vote of the shareholders. The number of votes cast for the amendment by each voting group entitled to vote separately on the amendments were sufficient for approval by that voting group.

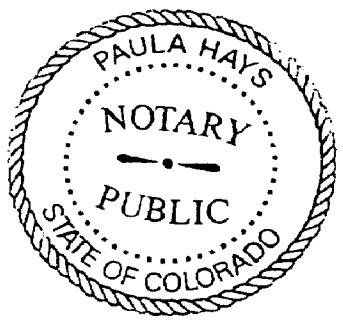
