**AMENDMENT TO**  
**TRADEMARK COLLATERAL ASSIGNMENT OF SECURITY**

WHEREAS, Colt's Manufacturing Company LLC (f/k/a Colt's Manufacturing Company, Inc.), a limited liability company formed under the laws of Delaware, located at 545 New Park Avenue, West Hartford, Connecticut ("Assignor"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A and including certain other foreign patents shown in the attached Schedule A; and

WHEREAS, Assignor is obligated to the Connecticut Development Authority (the "CDA") pursuant to a certain Amended and Restated Reimbursement and Security Agreement, dated as of November 28, 2001, between Assignor and the CDA (as the same may be amended, modified, restated or supplemented from time to time, the "Agreement"); and

WHEREAS, for good and valuable consideration, Assignor granted to CDA on or about November 28, 2001 a security interest in and to the Marks (the "Original Assignment"), together with the registrations and applications therefor and the goodwill related thereto and rights to sue and recover for infringement of trademarks, which security interest was to secure all Assignor's obligations to the CDA as defined in the Agreement and in accordance with the terms and provisions thereof.

WHEREAS, Schedule A to the Original Assignment contained inaccuracies, which the parties wish to correct.

NOW THEREFORE, Schedule A to the Original Assignment is hereby amended in its entirety and is replaced by Schedule A attached hereto.

Assignor expressly acknowledges and affirms that the rights and remedies of the CDA with respect to the security interest granted hereby are more fully set forth in the Agreement.
