ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK ("Assignment") is executed and effective as of the 5th of NOVEMBER, 2002 (the "Effective Date") by Daniel Elroi, an individual whose address is 820 S. NOW THEREFORE, in exchange for the sum of five thousand dollars (\$5,000.00) and other good and valuable consideration, the sufficiency of which is hereby acknowledged, Daniel Elroi hereby irrevocably sells, assigns and transfers to ERDAS, and ERDAS hereby accepts, Daniel Elroi's full and entire worldwide right, title and interest, in and to:

(i) the "MAPCOMPOSER" trademark and trade name, together with the good will of the business in which the mark is used, or with that part of the good will of the business connected with the use of and symbolized by the mark, and together with the associated U.S. Trademark Registration No. 2,247,442, along with any priorities, rights or registrations resulting therefrom;


(ii) any and all common law rights in and state trademark registrations and applications for marks incorporating the terms "MAPCOMPOSER;" and

(iii) any and all rights and causes of action to recover past, present, or future damages, royalties, fees, profits, or other relief, including equitable or injunctive relief, arising from infringement of the Mark and to which Daniel Elroi is or would have been entitled had this Assignment not been made.

The Mark is to be held and enjoyed by ERDAS for the exclusive use and benefit of ERDAS and ERDAS' representatives, successors, and assigns, as fully and entirely as the same would be held and enjoyed by Daniel Elroi had this Assignment not been made.
