TRADEMARK ASSIGNMENT

2. **Representations and Warranties.** Assignor represents and warrants to Assignee that: (1) Assignor possess all right, title and interest in and to the Trademarks; (2) the Trademarks are free of any security interest, license or other restriction; (3) the Trademarks are not subject to any outstanding injunction, judgment, order, decree, ruling, or charge; (4) no action, suit, proceeding, hearing, investigation, charge, complaint, claim, or demand is pending or, to the Knowledge of any of the Hover-Davis Stockholders and the directors and officers of Hover-Davis, is threatened which challenges the legality, validity, enforceability, use, or ownership of the Trademarks; and (5) Assignor has never agreed to indemnify any Person for or against any interference, infringement, misappropriation, or other conflict with respect to the Trademarks. Capitalized terms not defined herein shall have those definitions as set forth in the Asset Purchase Agreement dated September 6, 2002 by and between Assignor and Assignee.
3. **Further Assurances.** Assignor agrees to perform any further acts and execute and deliver any further documents which may be reasonably necessary to carry out the provisions of this Assignment.
