



TRADEMARK ASSIGNMENT

WHEREAS, LeCroy S.A., a corporation duly organized and existing under the laws of Switzerland, and having a place of business at 2, Rue Pre-de-la-Fontaine, CH-1217, Meyrin 1, Switzerland, (hereinafter "ASSIGNOR"), has adopted, used and is using the Trademark, "PROBUS," which is registered in the United States Patent and Trademark Office, Registration No. 1,994,287, dated August 20, 1996, and owns the trademark registration thereof, and the goodwill represented thereby; and

WHEREAS, LeCroy Corporation, a corporation duly organized and existing under the laws of the State of Delaware, and having a place of business at 700 Chestnut Ridge Road, Chestnut Ridge, NY 10977-6499, (hereinafter "ASSIGNEE"), is desirous of acquiring the trademark, "PROBUS" and U.S. Registration No. 1,994,287, and the goodwill represented thereby;
