- 3) GALLS RANGE-PRO, U.S. Trademark Registration No. 2,578,455 registered June 11, 2002.



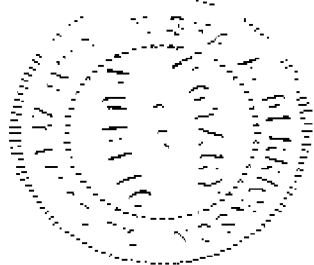


