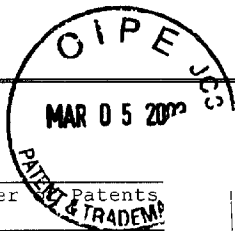


WHEREAS, Assignee is desirous of acquiring all rights to the Marks, and the registrations therefor;
