TRADEMARK ASSIGNMENT

WHEREAS, Assignor is desirous of assigning back to Assignee the entire right, title and interest of Assignor in and to said Trademarks;


NOW, THEREFORE, for ten (10) dollars and other good and valuable consideration, the receipt of which is hereby acknowledged:

2. Assignee agrees that it has sole responsibility and discretion for all maintenance costs and all other costs and expenses associated with the Trademarks.
3. This Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
4. This Assignment is to be effective as of the date this Assignment is executed by Assignor.


