**CONFIRMATORY TRADEMARK/SERVICE MARK ASSIGNMENT**

This Confirmatory Trademark Assignment (this "Assignment") is made on January 2, 2003 by and between Resort Rent-A-Car, Inc., a Colorado corporation (hereinafter "Assignor") and National Car Rental, Arizona, Inc., an Arizona corporation (hereinafter "Assignee")

WHEREAS, the Assignor was the owner of all right, title and interest in and to the Trademarks and Service Marks listed on the attached Exhibit A (hereinafter "the Marks"); and

WHEREAS, Assignor was desirous of assigning, and Assignee was desirous of obtaining, all right, title and interest in and to the aforementioned Marks; and

WHEREAS, the U.S. Bankruptcy Court for the District of Arizona approved Assignee's purchase of all of Assignor's trademarks, service marks, goodwill, trade names and intellectual property by order dated May 2, 2001; and


WHEREAS, effective as of May 2, 2001, Assignor assigned all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, to Assignee, but a formal written assignment was not executed in a recordable form; and

WHEREAS, the parties now wish to confirm the actual and legal transfer of the Marks from Assignor to Assignee;

NOW, THEREFORE, for good and valuable consideration previously paid, the sufficiency and receipt of which are hereby acknowledged, it is confirmed that effective as of May 2, 2001, Assignor did assign, transfer and convey, and hereby nunc pro tunc assigns, transfers and conveys, unto Assignee, all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement by the Marks, with the right to sue for, and collect the same for its own use and on behalf of its own successors, assigns, or other legal representatives.
