BETWEEN  
DEC INTERNATIONAL CORPORATION  
AND  
NATIONAL FIBERSTOK CORPORATION  
(Pursuant to Section 252)

AGREEMENT OF MERGER, made and entered into this 16th day of October, 1992, by and between DEC International Corporation, a Delaware corporation (the "Merging Corporation"), and National Fiberstok Corporation, a Delaware corporation (the "Surviving Corporation").

FIRST: The parties hereto agree that the Merging Corporation shall be merged into the Surviving Corporation upon the terms and conditions of this Agreement.

SECOND: The merger shall be carried into effect as set forth in this Agreement.

THIRD: No amendment is made to the Charter of the Surviving Corporation as part of the Merger, and the Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.

FOURTH: No shares of stock of the Surviving Corporation are to be issued for the shares of the Merging Corporation. However, as both the Merging Corporation and the Surviving Corporation are both wholly-owned subsidiaries of the same parent, upon the effective date of these Articles of Merger, the shares of stock of the Merging Corporation shall be cancelled.




