## COLLATERAL AGENCY AGREEMENT

COLLATERAL AGENCY AGREEMENT (the "*Agreement*"), dated as of June 23, 2000 (the "*Effective Date*") among the lenders party hereto (the "*Lenders*"), BANK OF AMERICA, N.A. ("*Bank of America*") and BANK ONE, NA ("*Bank One*"). Capitalized terms used herein and not specifically defined herein shall have the meanings ascribed to them in the Credit Agreement (as defined below) or the Intercreditor Agreement (as defined below).

## WITNESSETH:

WHEREAS, certain of the Lenders are party to that certain Second Amended and Restated Credit Agreement dated as of June 23, 2000 by and among UniGroup, Inc., a Missouri corporation, as Borrower, the lenders party thereto (the "*Bank Lenders*"), Bank One, as Agent for the lenders and Commerce Bank, N.A. and First Union National Bank, as Co-Agents (as amended and as the same may be further amended, modified, supplemented and restated from time to time, the "*Credit Agreement*");

WHEREAS, the Lenders are party to that certain Second Amended and Restated Intercreditor Agreement and Collateral Agency Agreement dated as of November 23, 1999 by and among The Prudential Life Insurance Company of America, the lenders named therein, Bank of America, in its capacity as collateral agent for the Bank Lenders and for the Noteholders (as defined therein) (as amended, modified, supplemented and restated from time to time, the "*Intercreditor Agreement*");

WHEREAS, the Intercreditor Agreement provides that Bank of America shall serve as Collateral Agent for the Bank Lenders and the holders of the Shelf Notes and Prudential Notes, and their successors and assigns;

WHEREAS, Bank of America desires to resign as Collateral Agent for the Bank Lenders and the holders of the Shelf Notes and Prudential Notes, and the Required Lenders under the Intercreditor Agreement desire to appoint Bank One to serve as Collateral Agent for the Lenders and the holders of the Shelf Notes and Prudential Notes; and

WHEREAS, Bank One is willing to serve as Collateral Agent for the Lenders and the holders of the Shelf Notes and Prudential Notes pursuant to the Intercreditor Agreement on the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the premises and the agreements hereinafter set forth, the parties hereto agree as follows:

SECTION 1. Replacement of Collateral Agent. As of the Effective Date, Bank of America resigns as Collateral Agent for the Bank Lenders and the holders of the Shelf Notes and Prudential Notes under the Intercreditor Agreement and the Required Lenders appoint Bank

One, pursuant to Section 4.09 of the Intercreditor Agreement, as Collateral Agent for the Bank Lenders and the holders of the Shelf Notes and Prudential Notes under the Intercreditor Agreement. Bank One hereby accepts such appointment and agrees to be bound by and to perform all of the rights, powers, privileges and duties of the Collateral Agent. Subject to Section 2 hereof, as of the Effective Date, Bank of America shall be discharged from its duties and obligations as Collateral Agent under the Intercreditor Agreement, the Credit Agreement, the Collateral Documents and the Credit Documents, but shall retain all rights under Sections 4.07, 4.08 and 4.11 of the Intercreditor Agreement with respect to all events prior to the Effective Date.

SECTION 2. Transfer of Collateral. The Required Lenders hereby direct Bank of America, on or promptly after the Effective Date (a) to transfer, assign and convey to Bank One, in its capacity as Collateral Agent for the Bank Lenders and the holders of the Shelf Notes and the Prudential Notes under the Intercreditor Agreement, any and all Collateral held by it pursuant to the Collateral Documents and the Credit Documents in its capacity as Collateral Agent, (b) to execute any and all instruments, agreements and other documents, including assignments of UCC financing statements, and to take such actions as may be reasonably requested by Bank One or the Required Lenders from time to time to properly transfer, assign and convey such Collateral to Bank One, as Collateral Agent for the Lenders and (c) to deliver such information relating to the Collateral and the administration of the Loans to Bank One as Bank One or the Required Lenders may reasonably request, provided that Bank of America shall be reimbursed for its reasonable out-of-pocket expenses and reasonable attorneys fees incurred in its capacity as Collateral Agent prior to the Effective Date or in connection with this Section 2.

SECTION 3. Collateral Documents and Credit Documents. All references in the Intercreditor Agreement, the Credit Agreement, the Collateral Documents and the other Credit Documents to Bank of America in its capacity as Collateral Agent shall from and after the Effective Date refer to Bank One in its capacity as Collateral Agent for the Lenders and the holders of the Shelf Notes and Prudential Notes under the Intercreditor Agreement. Except as specifically amended herein, the Intercreditor Agreement, the Credit Agreement, the Credit Documents and the Collateral Documents and all other documents, instruments and agreements executed in connection therewith shall remain in full force and effect. The execution, delivery and effectiveness of this Agreement shall not operate as a waiver of any right, power or remedy of the Lenders, nor constitute a waiver of any provision of the Intercreditor Agreement, the Credit Agreement, the Credit Documents or the Collateral Documents or any of the other documents, instruments and agreements executed in connection therewith.

SECTION 4. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws (including, without limitation, 735 ILCS 105/5-1 *et seq.*, but otherwise without regard to the conflict of laws provisions) of the State of Illinois.

SECTION 5. Counterparts. This Agreement may be executed by one or more of the parties hereto in any number of counterparts (including telecopy counterparts), each of which when so executed and delivered shall be an original, but all of which shall constitute one and the same instrument. It shall not be necessary in making proof of this Agreement to produce or account for more than one such counterpart.


