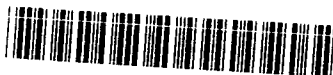

WHEREAS, Assignee is a successor to those portions of the business of Assignor to which the Marks pertain; and



Nothing in this confirmatory trademark assignment shall alter the terms of the First Trademark Assignment Agreement.


