BETWEEN:

(1) **Worldsport Networks Limited**, (the "**Assignor**"), a company in liquidation, registered in Ireland as company number 259193 and having its registered office at 74 Pembroke Road, Ballsbridge, Dublin 4, Ireland; and

(2) **Laureus Sports Awards Limited**, (the "**Assignee**"), a company registered in England and Wales and having its registered office at 15 Hill Street, London W1J 5QT.

Background:

(A) The Assignor is the proprietor of various trade marks and service marks registered or unregistered or the subject of applications for registration worldwide, including, without limitation, in Monaco, the United Kingdom, the USA, Japan and at the Community Trade Marks Registry and including, without limitation, those listed in Schedule 1 hereto ("the Trade Marks").

(B) The Assignor is the proprietor of various domain name registrations, including, without limitation, those listed in Schedule 2 hereto ("the Domain Names").

(C) The Assignor has agreed to assign all its rights title and interest in and to the Trade Marks and Domain Names to the Assignee for the consideration hereinafter mentioned.

THE PARTIES AGREE THAT:

1. In consideration of the sum of one hundred and one thousand pounds (£101,000) now paid by the Assignee to the Assignor (receipt of which sum the Assignor hereby acknowledges) the Assignor HEREBY ASSIGNS to the Assignee absolutely free from all liens, charges, security interests and/or encumbrances whatsoever the Trade Marks and Domain Names and all and any rights in and to the Trade Marks and Domain Names including the benefit of any applications for registration with the intention that when the applications are granted the registrations will vest in the Assignee together with any common law rights and all the goodwill associated with, symbolised by or attaching to the Trade Marks and Domain Names.
2. The Assignment hereby effected shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks and Domain Names (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks).
3. The Assignor hereby covenants that at the cost and request of the Assignee at any time and from time to time it will execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment.

This Assignment shall be governed by and construed in accordance with the laws of Ireland and the parties hereto submit to the exclusive jurisdiction of the Irish courts.
