RECITALS:


- A. Thermo Analytical, Inc. is the record owner of the trademark registration ("Trademark") listed on Schedule "A" attached hereto; and

Assignor hereby covenants and agrees to and with said Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, Lancaster Laboratories, LLC is transferring to Lancaster Laboratories, Inc. all of its right, title, and interest in and to the Trademark listed on Schedule "A" and the same is unencumbered and the Assignor has good and full right and lawful authority to sell and convey the same in the manner set forth herein. Assignor hereby warrants and represents to Assignee that no other person, firm, or corporation has been granted any rights by Assignor in respect of the Trademark listed on Schedule "A."


