WHEREAS, Assignor intends to convey to Assignee all its Intellectual Property Assets; and


WHEREAS, Assignee is desirous of acquiring said Intellectual Property Assets and registrations therefor;

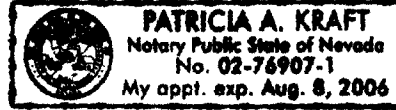
