**RELEASE OF SECURITY INTEREST OF
TRADEMARKS**

THIS RELEASE is granted by JPMORGAN CHASE BANK (f/k/a Chemical Bank), as Collateral Agent under the Security Agreement referred to below (the "Collateral Agent"), to JOHN M. SMYTH COMPANY, an Illinois corporation ("John Smyth").

WHEREAS, John Smyth entered into that certain Second Amended and Restated Subsidiary Guarantee Agreement, dated as of June 28, 1994 (the "Agreement");

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of June 28, 1994 (the "Security Agreement"), John Smyth granted to the Collateral Agent for the benefit of the Secured Parties (as defined therein) a security interest in all of John Smyth's right, title and interest in and to its trademarks and service marks, together with the goodwill of the business symbolized by such trademarks and service marks, and the applications or registrations thereof, including, but not limited to, the trademarks and service marks listed in Schedule A attached hereto (collectively, the "Marks") to secure the payment and performance of the obligations under the Agreement;

WHEREAS, the Security Agreement was recorded in the U.S. Patent and Trademark Office on August 18, 1994 at Reel 1203 at Frame 0384; and

WHEREAS, all of the obligations under the Agreement have been satisfied and John Smyth is entitled to the release of the security interest granted in the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent hereby releases the entire security interest in the Marks.
2. This release of security interest is being executed by the Collateral Agent with the intention that it be recorded in the U.S. Patent and Trademark Office to evidence that neither John Smyth nor any of the properties listed on Schedule A is subject to the security interest as set forth in the Security Agreement.
