

WHEREAS, under the terms of the Agreement, Assignor agreed to contribute, sell, transfer, assign, convey and deliver to Assignee certain trademarks, applications and registrations listed on Schedule A attached hereto ("Assigned Trademarks");

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to assume and receive all right, title and interest in and to the Assigned Trademarks.

NOW, THEREFORE, in consideration of certain good and valuable consideration set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby contribute, grant, transfer, assign and convey unto Assignee, Assignor's entire right, title and interest in and to the Assigned Trademarks, together with all associated goodwill thereof, and Assignor's right to recover past damages for infringement of the Assigned Trademarks. Assignee does hereby accept said assignment. Assignee shall be solely responsible for preparing and filing all additional documentation as may be required to perfect or record the assignments of the Assigned Trademarks with the United States Patent and Trademark Office or any foreign office or agency. Assignor agrees to provide Assignee its cooperation and assistance at Assignee's request in the implementation or perfection of this Assignment and to execute all documents that are necessary or appropriate to effectuate the purposes of this Assignment. This Assignment is in all respects subject to and limited by the terms, agreements, conditions, representations, warranties and obligations contained in the Agreement which are hereby fully incorporated herein by reference thereto. This Assignment may be executed in multiple counterparts, each of which shall constitute an original but all of which when taken together shall constitute one and the same instrument.
