PURSUANT TO the provisions of ALA. CODE § 10-2B-10.06 (1994 Repl.), the undersigned corporation adopts the following Articles of Amendment to its Restated Articles of Incorporation:

**FIRST:** The name of the corporation is MacMillan Bloedel Packaging Inc. (hereinafter referred to as the "Corporation").

**SECOND:** The following Amendment to the Restated Articles of Incorporation was adopted by the shareholders of the Corporation on December 17, 1999, in the manner prescribed by the Alabama Business Corporation Act:

The name of the Corporation is hereby changed to "Weyerhaeuser Packaging Inc." by amending Article 1 of the Restated Articles of Incorporation to read as follows:

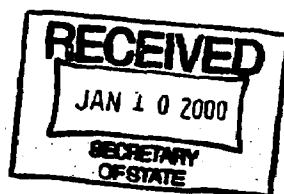
NAME

1.1\_ The name of the Corporation shall be **Weyerhaeuser Packaging Inc.**

**THIRD:** The number of shares of capital stock of the Corporation outstanding at the time of the adoption was 8,750 shares, divided into 1,750 shares of Class A common stock and 7,000 shares of Class B common stock; the number of shares entitled to vote thereon, by voting group, was 1,750 shares of Class A common stock and 7,000 shares of Class B common stock.

**FOURTH:** The number of shares voted for the amendment, by voting group, was 1,750 shares of Class A common stock and 7,000 shares of Class B common stock. The number of shares voted against such amendment was none.

**FIFTH:** The amendment does not effect an exchange, reclassification or cancellation of issued shares of the Corporation.

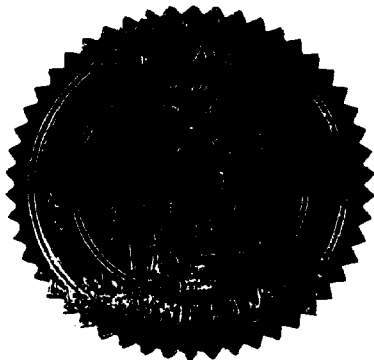
