TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into *nunc pro tunc* as of February 4, 2003 ("Effective Date") by and between Technical Concepts, LP in partnership with Technical Concepts, Inc., with its principal office at 1301 Allanson Road, Mundelein, Illinois 60060 ("Assignor"), and Technical Concepts, LLC, a Delaware limited liability company, with its principal office at 1301 Allanson Road, Mundelein, Illinois 60060 ("Assignor").

WHEREAS, Assignor and Assignee are parties to that certain Purchase Agreement dated February 4, 2003 (the "Agreement");

WHEREAS, pursuant to that Agreement, Assignor wishes to assign Assignee, and Assignee wishes to acquire from Assignor, the United States trademark application set forth on Schedule A attached hereto, together with the goodwill of the business associated therewith (the "Mark"); and

WHEREAS, Assignee is a successor to Assignor's business and that business is ongoing and existing.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee the entire right, title and interest in and to the Mark, for the United States and for all foreign countries, including, without limitation, any registrations and applications therefore, any renewals and extensions of the registrations, all goodwill of the business associated with the mark, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests that the Commissioner of Patents and Trademarks, and the corresponding entities in any applicable foreign countries, to record Assignee as the assignee and owner of the Mark.

Assignor shall, at Assignee's expense, take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney

or other documentation), reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Mark and this Assignment; (3) obtaining any additional trademark protection relating to rights assigned herein that Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or in any foreign country; and (4) in the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world.

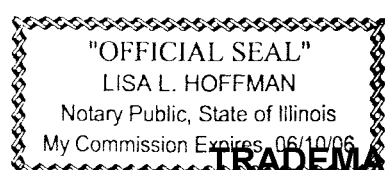

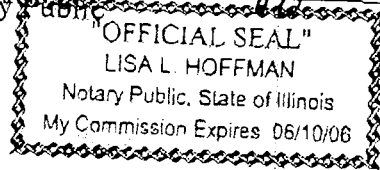

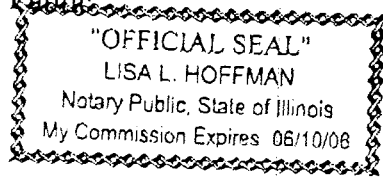
