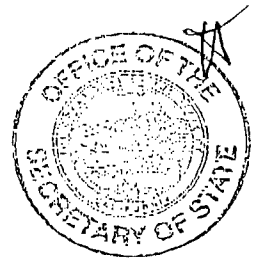

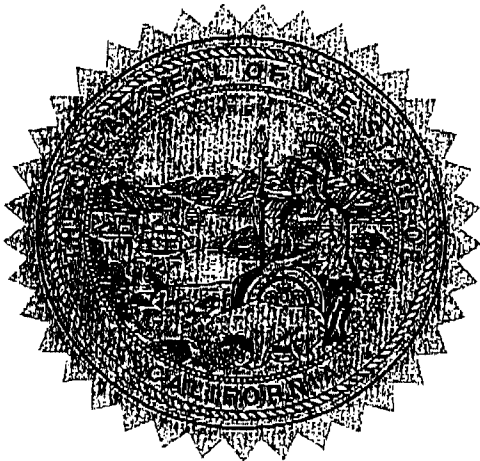

The undersigned hereby certifies that:

1. He is the President and Secretary of ViAlta.com, a California corporation.
2. Article I of the Third Amended and Restated Articles of Incorporation of ViAlta.com is amended to read as follows:

**ARTICLE I**

The name of this corporation is **Vialta, Inc.**

3. The foregoing amendment of the Third Amended and Restated Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing amendment of the Third Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of Common Stock of the corporation entitled to vote with respect to the foregoing amendment was 6,205,000, the total number of outstanding shares of Series A Preferred Stock of the corporation entitled to vote with respect to the foregoing amendment was 40,000,000, and the total number of outstanding shares of Series B Preferred Stock of the corporation entitled to vote with respect to the foregoing amendment was 51,000,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required, such required vote being more than 50% of the outstanding shares of Common Stock, Series A Preferred Stock and Series B Preferred Stock voting together as a single class. ~~There are no shares of Series C Preferred Stock outstanding.~~
