Whereas, the Assignor owns all rights and goodwill related to the marks; and

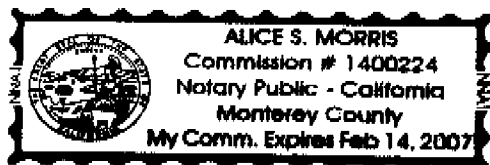
