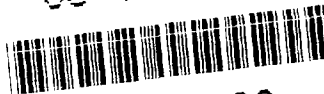

## TRADEMARK ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby assigns, transfers and conveys to the Assignee all its rights, title and interests to The Trademarks and the registrations therefor, together with the goodwill of the business which is symbolized by The Trademarks and together with the ongoing business of assignor in connection with The Trademarks as used or intended to be used.
