ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF  
THE SUPPLY ROOM COMPANIES, INC.

ARTICLE I

Name

The name of the Corporation is:

The Supply Room Companies, Inc.

ARTICLE II

Text of Amendments

The text of the amendments are as follows:

1. The provisions of Article I of the Articles of Incorporation shall be deleted and the following inserted in place thereof:

"I

The name of the Corporation is TSRC, Inc."

2. The provisions of Article III of the Articles of Incorporation shall be deleted and the following inserted in place thereof:

"III.

The number of shares of common stock which the Corporation shall have authority to issue is 1,500,000 shares, without par value. No holder of shares of any class of the Corporation shall have any preemptive or preferential right to purchase or subscribe to (i) any shares of any class of the Corporation, whether now or hereafter authorized; (ii) any warrants, rights or options to purchase any such shares; or (iii) any securities or obligations convertible into any such shares or into warrants, rights or options to purchase any such shares."

## ARTICLE III

Approval by Directors

The Board of Directors of the Corporation by unanimous written consent effective November 19, 1999, found the amendment to be in the best interest of the Corporation and directed that it be submitted to the shareholders of the Corporation entitled to vote thereon at the annual meeting of the shareholders to be held on December 15, 1999.

## ARTICLE IV

Approval by Shareholders

1. Notice of the annual meeting of the shareholders, together with a copy of the proposed amendment, was given in the manner prescribed by the Virginia Stock Corporation Act to all shareholders entitled to such notice.

2. On the record date, the total number of shares entitled to vote on the amendment was as follows:

11,250 shares of common stock

3. On December 15, 1999, the special meeting of shareholders was held and the amendment proposed by the Board of Directors was approved.

4. A total of 10,000 shares of common stock were present at the meeting, either in person or by proxy, constituting a quorum of the total number of shares entitled to vote on the amendment. The total number of votes cast FOR the amendment was 10,000 shares of common stock, and AGAINST the amendment was zero shares of common stock with zero shares abstaining. The number of votes cast for the amendment was sufficient for its approval.

## ARTICLE V

Effective Date

These Articles of Amendment shall become effective upon the issuance of the Certificate of Amendment.
