TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered as of the 3rd day of March, 2003 by Canadian Imperial Bank of Commerce, as Administrative Agent ("Lender"), to BSL, Inc., a Mississippi corporation ("BSL").

BACKGROUND

A. On August 8, 2000, BSL, executed and delivered to Lender a certain Intellectual Property Security Agreement ("BSL Security Agreement").

B. Pursuant to the BSL Security Agreement, BSL granted to Lender a security interest in the trademarks set forth on Exhibit A attached hereto (the "Security Interest").

C. The Security Interest was recorded in the United States Patent and Trademark Office ("USPTO") as set forth on Exhibit A attached hereto.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. Lender terminates and releases all of its rights, titles and interests in the trademarks set forth on Exhibit A.

2. BSL, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.


