**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

This Trademark Security Interest Release is granted and conveyed as of February 24, 2000, by Delta Opportunity Fund, Ltd., a British Virgin Islands corporation, c/o SBI Investments, Styno House, Upper Hatch Street, Dublin 2, Ireland (hereinafter referred to as "Delta"), in favor of Cephalon, Inc., a Delaware corporation, whose principal business address is 145 Brandywine Parkway, West Chester, Pennsylvania 19380 (hereinafter referred to as "Cephalon").

WHEREAS, the records of the United States Patent and Trademark Office ("PTO") reflect that Delta and Cephalon entered into a Trademark Security Agreement on February 25, 1999, under which Cephalon granted to Delta a security interest in Cephalon's interest in the trademark listed on the attached Schedule A (the "Mark").

WHEREAS, the PTO recorded this security agreement on February 26, 1999, at Trademark Reel 1863, Frame 0151;

WHEREAS, Cephalon has satisfied all of its outstanding obligations under the security agreement, and the parties seek to make a record of Delta's release to Cephalon of its security interest in the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Delta hereby releases, discharges, and relinquishes, as of February 24, 2000, its security interest in the Mark. Delta specifically acknowledges that the security interest is no longer effective, and that Delta does not own any rights to or have any ownership interest in the Mark.
