## ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS Assignee has provided such valuable consideration to Assignor;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby conveys and assigns to Assignee its entire right, title and interest in and to the Marks and to all trademark applications and registrations (including but not limited to U.S. Registration Nos. 2,189,374; 2,189,373; 2,184,056; 2,246,650; 2,265,528; and 2,240,317) and to any and all variations on the Marks or confusingly similar Marks.

2. Assignor hereby conveys and assigns to Assignee the portion of its business to which the Marks pertain, and the goodwill symbolized thereby.

3. Assignor is assigning and hereby assigns the Marks and the above-identified Trademark Registrations as part of the transfer of the entire business or portion thereof to which the Marks pertain as required by 15 U.S.C. §1060.
