WHEREAS, Bodet & Horst GmbH & Co. Kommanditgesellschaft, a corporation of the country of Germany, having an office at Rheiner Str. 59, 48477, Horstel, Germany ("Assignee"), is desirous of acquiring an undivided one-half of Assignor's interest in and to the Mark and Registration.


