ASSIGNMENT FOR U.S. REGISTERED TRADEMARKS

WHEREAS, Assignor is the owner of the U.S. Trademark MAR-FLEX, Registration Number 1,245,285, registered on July 12, 1983 (the "Trademark"); and


WHEREAS, Assignor agreed inter alia to sell, convey, transfer, assign and deliver the Trademark together with the registration thereof along with the goodwill symbolized thereby to Assignee as a condition of a sale which occurred on January 1, 1996 (the "Sale").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, convey, transfer and assign to Assignee the Trademark and all of Assignor's right, title and interest in and to the Trademark, including without limitation, (i) the goodwill of the business symbolized by the Trademark and (ii) all rights to sue and recover damages for any and all past infringements thereof, all of the same to be held and enjoyed by Assignee for its own use and for the use of its successors or assigns as fully and entirely as the same would have been enjoyed by Assignor if assignment thereof had not been made.

This Assignment is effective as of January 1, 1996 and is subject to the terms of said Sale and is given solely for purposes of separately evidencing the transaction contemplated thereby.
