



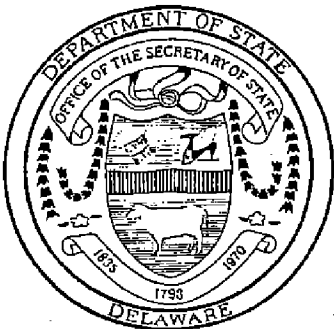

NEWS AMERICA PUBLISHING INCORPORATED, a corporation organized and existing under and by the laws of the State of Delaware (the "Company") DOES HEREBY CERTIFY that the Company owns all of the issued and outstanding capital stock of NEWS GROUP PUBLICATIONS, INC., a corporation organized and existing under and by the laws of the State of Delaware and that the Company, by resolutions of the Board of Directors of the Company, duly adopted in accordance with applicable law at a meeting of the Board of Directors of the Company held at the offices of the Company on December 21, 1984, determined to merge into itself said News Group Publications, Inc. and to change the name of the Company to NEWS GROUP PUBLICATIONS, INC., both the merger and the change of name to be effective January 7, 1985, which resolutions are in the following words:

(a) Effective as soon as the appropriate Certificate of Ownership and Merger is filed, the Company merge into itself News Group and thereupon assume all of its liabilities and obligations and be possessed of all of its estates, properties, rights, privileges and franchises;

(b) the name of the Company be changed to News Group Publications, Inc.;

(c) the Chairman, President or any Vice President and the Secretary or Assistant Secretary of the Company be and they hereby are directed to make and execute, under the corporate seal of the Company, a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge News Group into the Company and to assume the liabilities and obligations of News Group and to change the name of the Company to News Group Publications, Inc., and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware and a certified copy thereof in the office of the Recorder of Deeds of Kent County, State of Delaware; and

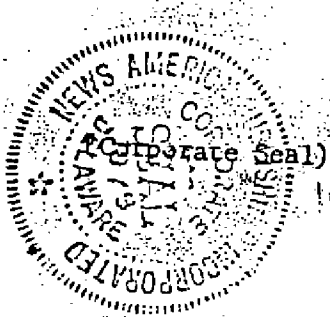

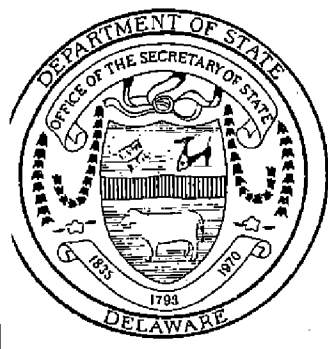

News Group Publications, Inc. desiring to merge with News America Publishing Incorporated pursuant to the provisions of Section 251(c) of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY as follows:

FIRST: That the name and state of incorporation of each constituent corporation are:

News Group Publications, Inc.	Delaware
News America Publishing Incorporated	Delaware

SECOND: That an agreement of merger has been approved, adopted, certified, executed and acknowledged by each constituent corporation in accordance with Section 251(c) of the General Corporation Law.

THIRD: That the name of the surviving corporation is News Group Publications, Inc. (whose name will be changed pursuant to Paragraph FOURTH to "News America Publishing Incorporated").

FOURTH: That the following amendments are to be made to the Certificate of Incorporation of News Group Publications, Inc., the surviving corporation:

Deleted Paragraph 4.

(i) Article "First" is deleted in its entirety and replaced by the following new Article:

"First: The name of the corporation (hereinafter called the "Corporation") is NEWS AMERICA PUBLISHING INCORPORATED."

(ii) Article "Fourth" is deleted in its entirety and replaced by the following new Article:

"Fourth: The total number of shares of stock which the Corporation is authorized to issue is 4000 shares of Common Stock having a par value of \$1.00 per share."

FIFTH: That each of the presently outstanding shares of stock of the surviving corporation is to be changed into one share of Common Stock, par value \$1.00 per share, of the surviving corporation, and each of the presently outstanding shares of News America Publishing Incorporated is to be changed into one share of Common Stock, \$1.00 par value per share, of the surviving corporation.


