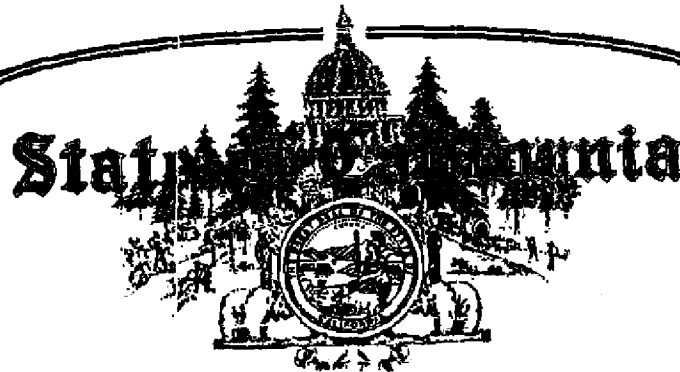

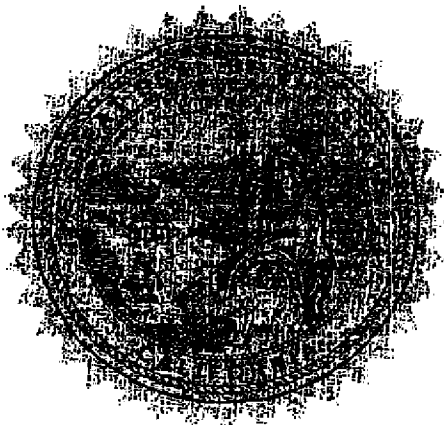

In connection with the short form merger of SUPERGO CORP. with and into BIKECOLOGY, INC. pursuant to Section 1110 of the California Corporations Code, Bob Martin and Donna Taylor hereby certify that:

1. They are the President/Assistant Secretary of the Board of Directors respectively, of BIKECOLOGY, INC., a California corporation (the "Surviving Corporation").
2. This Surviving Corporation owns all of the issued and outstanding shares of SUPERGO CORP., a California corporation (the "Disappearing Corporation").
3. The Board of Directors of the Surviving Corporation and the Disappearing Corporation duly adopted the following resolutions:

RESOLVED, that BIKECOLOGY, INC. shall merge SUPERGO CORP., its wholly-owned subsidiary, into BIKECOLOGY, INC. and assume all of its liabilities and obligations pursuant to and as required by Section 1110 of the California Corporations Code; and

RESOLVED, that the Surviving Corporation shall change its name to "SUPERGO CORP." such that Article I of the Articles of Incorporation of Bikecology, Inc. shall be amended to read as follows:
