## TRADEMARK SECURITY AGREEMENT – SHORT FORM

TRADEMARK SECURITY AGREEMENT dated March 25, 2003 made by **FLEISCHER'S BAGELS LLC**, a New York limited liability company having its principal place of business at 1688 North Wayneport Road, Macedon, New York 14502 (the "**Grantor**"), in favor of Manufacturers and Traders Trust Company ("M&T"), having its principal place of business at One M&T Plaza, Buffalo, New York 14240, as the "**Grantee**" (each as defined in the Credit Agreement referred to below).

The Grantor is party to the Credit Agreement dated March 25, 2003 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**") with M&T. Capitalized terms not otherwise defined herein shall have the same meanings as specified therefor in the Credit Agreement or the Security Agreement referred to below.

In connection with the Credit Agreement, the Grantor and the Grantee entered into a Security Agreement dated March 25, 2003 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**") with the other grantors party thereto, pursuant to which the Grantor has granted to the Grantee a lien on and security interest in, inter alia, all of the Grantor's rights, title, and interest in and to all Trademarks (as defined in the Security Agreement) of such Grantor, whether then owned or thereafter acquired or created by such Grantor, including, without limitation, the trademark applications and registrations therefor listed on Schedule A hereto (the "**Trademark Collateral**") and the goodwill of the business symbolized thereby.

The parties desire to record the Grantor's grant of the security interest in the Trademark Collateral to the Grantee with the United States Patent & Trademark Office.


**NOW, THEREFORE**, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees with the Grantee as follows:

1. The Credit Agreement and Security Agreement and their terms and provisions are incorporated herein in their entirety.
2. The Grantor grants to the Grantee a lien on and security interest in all of its right, title, and interest in and to the Trademark Collateral and the goodwill of the business symbolized by the Trademark Collateral.
