The undersigned certifies that:

1. He is the president and secretary of eLabor.com, Inc., a California corporation.
2. Article 1 of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:  
The name of the corporation is eLabor, Inc.
3. The Board of Directors has duly approved the foregoing amendment of Articles of Incorporation.
4. The shareholders have approved, by the required vote, the foregoing amendment of Articles of Incorporation in accordance with Section 902, California Corporations Code. The total number of outstanding shares of Common Stock of the corporation is 14,054,319. The total number of outstanding shares of Series A Preferred Stock is 1,984,000. The total number of outstanding shares of Series B preferred Stock is 4,578,702. The number of shares voting in favor of the amendment, voting as a single class, equaled or exceeded the vote required. The percentage vote required was more than 50%.
