ASSIGNMENT OF TRADEMARK

WHEREAS, MALLINCKRODT INC. ("Assignor"), a Delaware corporation with principal offices at 675 McDonnell Boulevard, P. O. Assignor covenants and agrees that, at any time and from time to time, it will, upon the request of Assignee, do, execute, acknowledge, and deliver, or cause to be done, executed, acknowledged, and delivered, all such further acts, deeds, instruments, powers of attorney, or assurances as may be required for the better granting, assigning, conveying, and transferring to Assignee of the Trademark hereby conveyed.

The provisions hereof shall inure to the benefit of and be binding upon the successors and assigns of Assignor and Assignee.

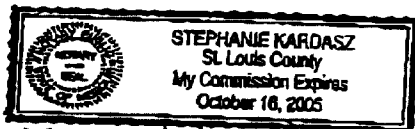
