RELEASE OF SECURITY INTEREST
(PATENT, TRADEMARK, COPYRIGHT)

This RELEASE OF SECURITY INTEREST (PATENT, TRADEMARK, COPYRIGHT) (this "Release") is granted on July 8, 2003 by HELLER FINANCIAL, INC., a Delaware corporation located at 500 West Monroe, Chicago, Illinois 60661, ("Assignor") as Senior Agent on behalf of the Agents, Senior Lenders, Subordinated Agent and Subordinated Creditors, all as defined in the Security Agreement dated October 31, 2000 (as amended, supplemented, restated or otherwise modified from time to time, the "Security Agreement") between Assignor and, among others, RECOTON CORPORATION, a New York corporation, located at 2950 Lake Emma Road, Lake Mary, Florida 32746, ("Recoton"), INTERACT ACCESSORIES, INC., a Delaware corporation ("InterAct"), RECOTON AUDIO CORPORATION, a Delaware corporation ("Recoton Audio"), RECOTON HOME AUDIO, INC., a California corporation ("RHAI"), RECOTON ACCESSORIES, INC., a Delaware corporation ("Accessories") (collectively, "Assignee"), as follows:

WHEREAS, Assignee and Assignor entered into a Patent Security Agreement, dated as of October 31, 2000 (the "PSA"), which was recorded in the U.S. Patent and Trademark Office at Reel 011410/Frame 0372;

WHEREAS, Assignee and Assignor entered into a Trademark Security Agreement, dated as of October 31, 2000 (the "TSA"), which was recorded in the U.S. Patent and Trademark Office at Reel 002213/Frame 0615;

WHEREAS, Assignee and Assignor entered into a Copyright Security Agreement, dated as of October 31, 2000 (the "CSA"), and together with the Security Agreement, the PSA and the TSA, the "Agreements";

WHEREAS, pursuant to the Agreements, Assignee granted, conveyed, assigned, and pledged to Assignor as Senior Agent on behalf of the Agents, Senior Lenders, Subordinated Agent, and Subordinated Creditors, a continuing security interest, lien and mortgage in and to all rights, title, and interest in, among other collateral, certain of those patents listed on Schedule A hereto (the "JAX Patents"), certain of those trademarks and trademark applications listed on Schedule B hereto (the "JAX Trademarks") and certain of those copyrights listed on Schedule C hereto (the "JAX Copyrights", and together with the JAX Patents and the JAX Trademarks, the "JAX Intellectual Property") all reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations of the JAX Intellectual Property, all rights corresponding to the JAX Intellectual Property throughout the world, and all proceeds of the JAX Intellectual Property including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit, and the right to sue for past infringements of the JAX Intellectual Property, together with the proceeds and products of the JAX Intellectual Property (collectively, the "JAX IP Collateral") to secure the payment, and performance of the Secured Obligations, as defined in the Agreements (the "Security Interest");

WHEREAS, Recoton, Recoton Audio, RHAI, RECOTON MOBILE ELECTRONICS, INC., a Delaware corporation, RECOTON INTERNATIONAL HOLDINGS, INC., a Delaware corporation and RECOTON CANADA LTD., an Ontario corporation (the "Audio Sellers") have informed the Senior Agent that they have entered into that certain First Amended and Restated Asset Purchase Agreement with JAX Assets Corp. ("JAX") and Audiovox Corporation dated as of June 2, 2003 (the "JAX/Audiovox Sale Agreement"), pursuant to which Audio Sellers have agreed to sell certain of their assets, including, without limitation, the JAX Intellectual Property, to JAX (such sale, substantially in accordance with the JAX/Audiovox Sale Agreement, is hereinafter referred to as the "JAX/Audiovox Sale");

WHEREAS, on the "Closing Date", as defined in the JAX/Audiovox Sale Agreement, Audio Sellers expect to receive initial proceeds from the JAX/Audiovox Sale, net of all (i) commissions and other reasonable and customary transaction costs, fees and expenses properly attributable to such transaction and payable by Recoton in connection therewith, (ii) transfer taxes, (iii) amounts payable to holders of senior liens (other than those of Assignor), if any, and (iv) an appropriate reserve for income taxes in accordance with GAAP in connection therewith, in excess of \$35,000,000 (such proceeds, net of the items described in clauses (i)-(iv), being hereafter referred to as the "Initial JAX Net Proceeds");

WHEREAS, in conjunction with the JAX/Audiovox Sale, Assignee requests that Assignor release its Security Interest (as defined below) in the JAX IP Collateral; and

WHEREAS, Assignor, desires to release its Security Interest in the JAX IP Collateral except for (i) all proceeds of the JAX/Audiovox Sale, including, without limitation, the Initial JAX Net Proceeds and any subsequent proceeds, (ii) all of Recoton's and its Subsidiaries' claims, rights and interests in, to and under the JAX/Audiovox Sale Agreement, and (iii) all property of Assignee expressly described in the JAX/Audiovox Sale Agreement as not being sold as part of the JAX/Audiovox Sale (the JAX IP Collateral excluding such excepted property being the "Released Collateral").


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases and terminates all liens, security interests and all right, title and interest (collectively, "Security Interest") in and to the Released Collateral granted, pledge, conveyed, transferred and set over to Assignor pursuant to the Agreements and any and all security agreements, pledges, or other documents creating any Security Interest and entered into in connection with the obligations secured pursuant to the Agreements (such security agreements, pledge agreements and other documents, collectively being, the "Loan Documents"), and reassigns any and all right, title and interest in the Released Collateral to Assignee. The release, termination and reassignment of the Security Interest in and to the Released Collateral shall not affect the Security Interest of Assignor in any and all other collateral, which Security Interest shall continue in full force and effect. Assignor hereby waives notice of prepayment, termination or any other notice required pursuant to the Loan Documents. Upon execution and delivery of this Release, Recoton Japan, Recoton German Holdings GmbH and Recoton Italia S.r.l. will cease to be a parties to the Loan Documents to which they are presently parties and all of their rights and obligations under such Loan Documents shall be terminated and all references to Recoton Japan, Recoton German Holdings GmbH or Recoton Italia S.r.l. in such Loan Documents shall be deemed deleted and shall have no meaning or

effect. Assignor hereby agrees to authorize, execute and deliver to JAX (or such other person as is designated thereby) each other instrument, notice, release or certificate as JAX may reasonably request to more fully effectuate the release and termination of Security Interests in the Released Collateral.
