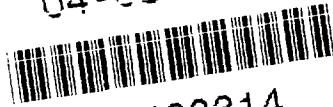

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Trademarks to Assignee;




