RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 28, 2003 ("Effective Date") by and between Bontex, Inc. ("Debtor"), and Congress Financial Corporation ("Lender");

WHEREAS, Debtor and Lender entered into the Trademark Security Agreement (the "Trademark Security Agreement") dated as of January 26, 2000 pursuant to the terms and conditions of a Loan and Security Agreement dated January 26, 2000;

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Debtor granted to Lender a continuing security interest in and to the Trademarks (as defined in the Trademark Security Agreement), including but not limited to the trademarks, service marks and trade names set forth on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded on February 11, 2000 among the trademark records of the Patent and Trademark Office in Reel 002031, Frame 1970; and

WHEREAS, Debtor has paid all of its outstanding indebtedness to Lender;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases its security interest in and reassigns, transfers and conveys to Debtor, all right, title and interest which Lender has in and to the Trademarks.


