WHEREAS, Coloplast Corp. (Assignor), a corporation organized under the laws of Georgia, domiciled and doing business at 1955 West Oak Circle, Marietta, Georgia 30062-2249 U.S.A. is the present title owner of the "LUXA AIRE" trademark and U.S. Trademark Application Serial No. 75/831,127 (now U.S. Registration No. 2,625,658) by reason of an earlier assignment dated June 26, 2001 between Coloplast A/S and Coloplast Corp (Reel/Frame 002324/0957 as recorded with the U.S. Patent and Trademark Office on July 9, 2001);

AND WHEREAS, Coloplast A/S (Assignee), a corporation organized under the laws of Denmark, domiciled and doing business at Høltedam 1 DK-3050, Humlebaek, Denmark is desirous of correcting a possible defect in title occasioned, in part, by the U.S. Patent and Trademark Office which issued a Notice of Allowance on September 11, 2001 in the name of Coloplast A/S rather than Coloplast Corp. by re-acquiring all the right, title, and interest in and to the "LUXA AIRE" trademark and U.S. Trademark Application Serial No. 75/831,127 and the registration that issued therefrom.
