## TRADEMARK ASSIGNMENT

**VPI Mirrex, LLC**, a Delaware limited liability company, whose address is c/o VPI, LLC 3123 S. 9<sup>th</sup> Street, P.O. Box 451, Sheboygan, Wisconsin 53082 ("Assignor"), has entered into an Asset Purchase Agreement, dated as of February 14, 2003, with **Klöckner Pentaplast of America, Inc.**, a Delaware corporation, whose address is 3585 Klöckner Road, P.O. Box 500, Gordonsville, Virginia 22942 ("Assignee"), pursuant to which Assignee shall acquire certain assets owned by Assignor.

Among the assets to be acquired pursuant to the Asset Purchase Agreement are marks owned by Assignor. Assignor desires to transfer to Assignee all of its rights and interests in the marks MIRRAN, MIRREX, and MIRREX 1025 (collectively, the "Marks"), together with the goodwill that Assignor has developed in the Marks (the "Goodwill"). Assignee desires to acquire the Marks, together with the Goodwill.

Consequently, in fulfillment of these objectives, and in furtherance of the provisions of the Asset Purchase Agreement, Assignor desires to assign the Marks and the Goodwill to Assignee pursuant to this Assignment.

NOW, THEREFORE, for good and valuable consideration offered by Assignee to Assignor pursuant to the Asset Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor has agreed to sell and has hereby sold, assigned, and transferred unto Assignee and its successors and assigns Assignor's entire right, title, and interest in and to the Marks and the Goodwill, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its parents, subsidiaries, affiliates, successors, assigns, licensees, and legal representatives, as such rights would have been held and enjoyed by Assignor had this Assignment not been made. Without limitation of the foregoing, the rights hereby assigned to Assignee include Assignor's rights in all issued registrations for the Marks, as identified on the Schedule to this Assignment. Assignor shall not, at any time, contest the validity of the Marks or the Goodwill, or take any action that would impair the value of the Marks or the Goodwill.

2. Assignor represents and warrants that it has the authority to make and enter into this Assignment and that such Assignment will not violate Assignor's obligations to or with any third party.

3. Assignor agrees to execute any other documents or to provide any further materials or documentation in its possession necessary in order to fulfill the provisions of or the purpose of this Assignment or to substantiate Assignee's ownership of the Marks and the Goodwill.

4. This Assignment is binding upon the parties and their respective heirs, successors, assigns, trustees, and representatives.
