TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into this July 10, 2003, by and between E. M. MATSON, JR. CO., INC. a Washington corporation ("Assignor") and MATSON, LLC, a Washington limited liability company ("Assignee").

WHEREAS, Assignor is the owner of the trademarks/service marks and the corresponding registrations and applications in the U.S. Patent and Trademark Office as more fully described in Exhibit A attached hereto, which is incorporated herein by reference (collectively the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors do hereby convey, grant, assign and deliver to Assignee all right, title and interest in and to the Trademarks worldwide, and any other registrations or applications therefor in the United States or any foreign jurisdiction, together with the good will of the business symbolized by the Trademarks and all claims and causes of action relating to infringement of the Trademarks, including the right to collect damages for such infringements, the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns.

Assignors will reasonably assist Assignee in obtaining or providing such further documents which may be reasonably required to transfer title of the Trademarks to Assignee.

This agreement may be executed in counterparts, which taken together as a whole may be considered one agreement.

The parties hereto have executed this Assignment as of the date first written above.
