
1. The name of the corporation is Vanson, Inc.

ARTICLE I. NAME

The foregoing amendment to the Second Amended and Restated Articles of Incorporation was adopted by unanimous consent of the directors of Vanson, Inc. and the Series B Preferred Stock holders of Vanson, Inc. in accordance with the provisions of RCW 23B.10.030 and Article 3.8.2(c) of the Second Amended and Restated Articles of Incorporation of Vanson, Inc. on the 6th day of May, 2002. No other shareholders are entitled to vote on this amendment.
