TRADEMARK ASSIGNMENT

WHEREAS, Assignor is the record owner of the trademark ESTRELLA COLLECTION (the "Mark") and the related United States Application Serial No. 78/220,998 (the "Application"); and

WHEREAS, Assignor and Assignee are parties to a certain Trademark Sale Agreement, dated even date herewith, pursuant to which Assignor assigned, transferred and conveyed to Assignee all of its right, title and interest in and to the Mark and the Application, together with the goodwill of the business, and all common law rights, associated with the Mark; and

WHEREAS, Assignor and Assignee desire to confirm the assignment of the Mark and the Application to Assignee;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such confirmatory assignments and other legal documents as Assignee, or its counsel, may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of each of the rights hereby conveyed.
