Registrant hereby requests recordation of the change of name that occurred on April 12, 1990 from Ovako Steel AB, as owner of the Mark, to Ovako Aktiebolag.


Aktiebolaget SKF initially filed the application for the mark CROMAX (hereinafter the "Mark") on December 27, 1978. Following registration of the Mark, Aktiebolaget SKF conveyed its entire interest in the Mark by way of assignment to Ovako Steel AB on November 9, 1988. This assignment was promptly recorded at the United States Patent and Trademark Office at Reel 0632, Frame 0746.

The second recorded assignment of the Mark was from Ovako Aktiebolag to Ovako Steel Aktiebolag, executed on December 15, 1992 and recorded at Reel 0928, Frame 0314. This conveyance appears to create a break in the chain of title of the Mark. However, a change of name of the owner of the Mark occurred on April 12, 1990, but was never recorded. On April 12, 1990, Ovako Steel AB, as the owner of the Mark on that date, changed its name to Ovako Aktiebolag, the assignor in the aforementioned second recorded assignment that was recorded at Reel 0928, Frame 0314. Through this change in name there is continuity in the Mark's chain of title.

Accordingly, recordation of the change of name effective April 12, 1990 from Ovako Steel AB, as owner of the Mark, to Ovako Aktiebolag is hereby requested.
