ASSIGNMENT OF TRADEMARKS

WHEREAS, the Management of **Trelleborg Wheel Systems Americas, Inc.**, a Delaware corporation, having a business address of **61 State Route, 43 North, Hartville, Ohio 44632, USA**, has discovered that there has previously been an erroneous assignment of intellectual property rights from **Trelleborg Industri AB (Publ)**, a Swedish corporation, having a business address of **Nygatan 102, SE-231, Trelleborg 45 Sweden**, to **Trelleborg Wheel Systems Americas, Inc.** and furthermore that there was an additional erroneous assignment of intellectual property rights from **Trelleborg Monarch, Inc.**, a Delaware corporation having a business address of **61 State Route, 43 North, Hartville, Ohio 44632, USA**, to **Trelleborg Wheel Systems Americas, Inc.** The Management of Trelleborg Wheel Systems Americas, Inc. wishes to correct the error made in the previous assignments of intellectual property rights. The effect of the present Assignment shall be to transfer all rights, interest and title in the trademarks contained on Schedule A, which is attached hereto and incorporated herein by reference, to **Trelleborg Industri AB**, a Swedish corporation, having a business address of **Nygatan 102, SE-231, Trelleborg 45 Sweden**.

BY PREVIOUS UNDERSTANDING of the Management of both **Trelleborg Wheel Systems Americas, Inc.** and **Trelleborg Industri AB**, the effective date of this Assignment shall *nunc pro tunc* be March 15, 2000.

WHEREAS, **Trelleborg Wheel Systems Americas, Inc.** and **Trelleborg Industri AB** are the owners of the entire right, title, and interest in the trademarks listed on Schedule A and are the record title holders of said trademarks; and

WHEREAS, **Trelleborg Industri AB**, is desirous of purchasing the entire right, title, and interest in said trademarks including the goodwill of the business symbolized by said trademarks, and

WHEREAS, **Trelleborg Industri AB** desires to obtain the entire legal title to said trademarks and to the registrations thereof;

NOW, THEREFORE, in consideration of the premises and of One Dollar (\$1.00) and of other good and valuable consideration, the sufficiency of which is hereby expressly acknowledged, **Trelleborg Wheel Systems Americas, Inc.** by these presents hereby assigns, transfers, conveys, and sets over unto said **Trelleborg Industri AB**, its successors, assigns and legal representatives, the entire right, title, and interest to and under said trademarks, together with the goodwill of the business in connection with which said trademarks were and are used, and all rights incident thereto;

Said **Trelleborg Wheel Systems Americas, Inc.** hereby releases, assigns, and transfers unto said **Trelleborg Industri AB**, its successors, assigns and legal representatives, all rights, title, and interest, claims and demands whatsoever said **Trelleborg Wheel Systems Americas, Inc.** had in, to and by, under and through, said trademarks, including all claims for any and all past infringement thereof and the right to sue therefor;

ALL OF THE SAME to be held and enjoyed by said **Trelleborg Industri AB** for its own use and behoof and for its successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said **Trelleborg Wheel Systems Americas, Inc.** had this Assignment not been made.
