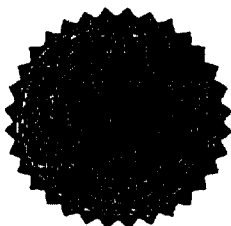

DOES HEREBY CERTIFY:

FIRST: That the Corporation owns all of the outstanding shares of About, Inc., a corporation organized and existing under the DGCL.

SECOND: That the Corporation, by the following resolutions of its Board of Directors, duly adopted at a telephonic meeting of its members on January 31, 2002, determined to merge About, Inc. into itself on the terms and conditions set forth in such resolution:

RESOLVED, that About, Inc. be merged with and into the Corporation and that the Corporation be the surviving corporation in such merger.

FURTHER RESOLVED, that the merger shall become effective upon the date and time of the filing of a Certificate of Ownership and Merger with the Secretary of State of Delaware.


FURTHER RESOLVED, that upon the effectiveness of the merger, the Corporation shall assume all of the liabilities and obligations of About, Inc.

FURTHER RESOLVED, that upon the effectiveness of the merger, the name of the Corporation shall be changed to "About, Inc." and Article I of the Second Amended and Restated Certificate of Incorporation of the Corporation shall be amended to read as follows:

"The name of the corporation is About, Inc. (the "Corporation")."
