Marks and the registrations of said Marks and the right to recover damages for past infringement, if any.

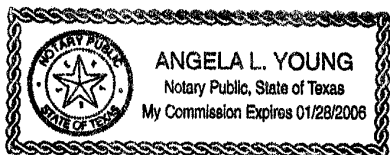
