TRADEMARK ASSIGNMENT

This Trademark Assignment is made and entered into on this 29th day of August, 2003 by and between Proxim Wireless Networks, Inc., a Delaware Corporation ("Assignor"), and Proxim Corporation, a Delaware Corporation ("Assignee"), with reference to the following:

2. Further Assurances. Assignor will execute all instruments and documents of further assurance and will do any and all such acts as may be reasonably required to carry out its obligations and to consummate the transactions contemplated herein.
