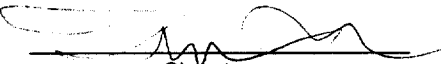

FIRST: That the name of the corporation as it appears on the records of the Secretary of State of Delaware is Delta Surprenant Wire and Cable Inc.

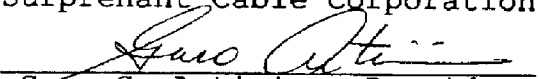
SECOND: That it is organized under the laws of the State of Connecticut.

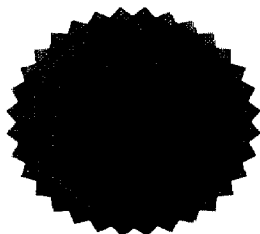
