The undersigned corporation, organized and existing under and by virtue of the General Corporation Law of the State of Delaware, **DOES HEREBY CERTIFY THAT:**

FIRST: That the name and state of incorporation of each of the constituent corporations to the merger (the "Constituent Corporations") are as follows:

EIGHTH: That the Merger shall be effective upon filing of this Certificate of Merger with the Secretary of State of the State of Delaware in accordance with Section 103(d) of the GCL.

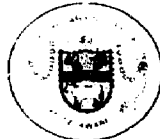

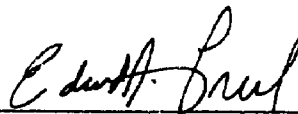
