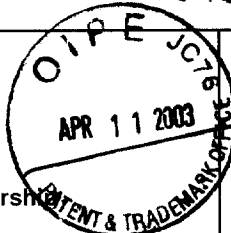

Preamble


